- All other business, which may come before the meeting or any adjournment thereof.

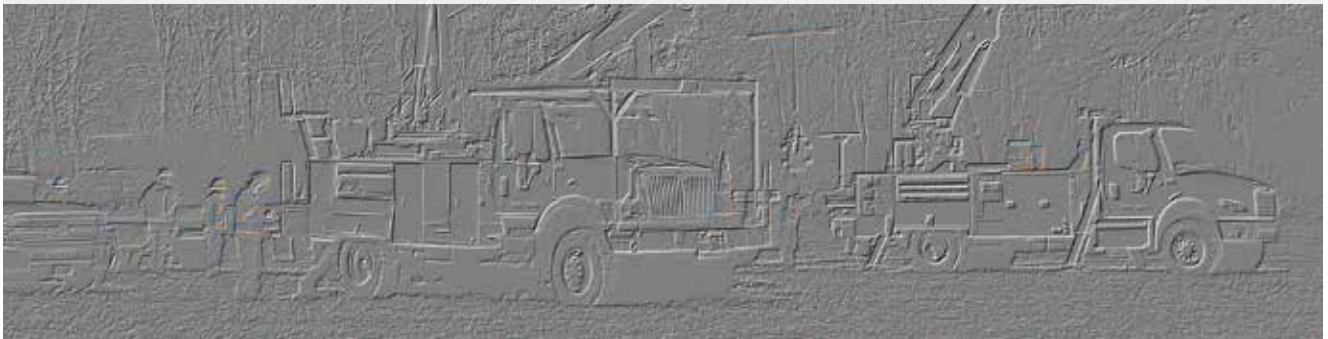

By Petition:

Any 100 members of the Cooperative acting together may make nominations in writing, listing the nominees separately with respect to the particular term and the particular directorate district from which they are nominated, not less than (40) business days prior to the meeting.
